In the last month we had a contractor blitz in Green Bay. This is where all of us organizers get together and visit a lot of contractors in the area in a short time. We had five teams and visited five contractors each on Monday night.

Then we each visited fifteen contractors each on Tuesday. Our message was, are the non-signatory contractors ready for electrical licensing that goes into effect as of April 2013? This was a great ice breaker and led into other questions they had about our training. We then had a debriefing on Wednesday at our State Organizers meeting. Over all, the reception we got from the non-signatory contractors was positive. All locals will be participating in this for all areas of the state.

In the last month we have continued to visit non-signatory contractors in our area. We have visited Searl Electric, Great Lakes Electric, Badger Electric, Bear Electric, No Shorts Electric, Davis Electric, Eagle Electric of Sauk Prairie, Hills Wiring,

The Electrician, Action Heating, Cooling and Electric, Specialized Electric and North Side Electric. We have been asking if they are ready for the electrical licensing law.

Some of them are and some are paying their employees to go to classes for their CEU's.

Most of the employees have to take care of the cost of classes for their CEUs. I have talked to guys out in the field about the way we cover the cost of classes for CEUs for our members.

I would like to thank the Brothers and Sisters who diligently continue to keep their eyes open for things happening in our jurisdiction.

Affordable Health Care Act or Obama Care?

One thing that is has become a certainty in politics is that often the name of a policy or proposal is more important than what it actually does. In our current society we seem to have little time to actually understand how something works but have no shortage of 'talking heads' willing to tell us and scoff using names and titles while never actually discussing what it really is.

On the Affordable Care Act/Obama Care we hear a lot of contradictory information. It will bust the budget vs. it will save money, it will provide health insurance for many more people vs. it will cause employers to drop insurance, it gives more affordable options on insurance vs. it is a government takeover of our health care system, it will have bureaucrats in government deciding what care you get vs. it will keep insurance companies from denying you care, it will cost less for health insurance vs. it will drive up the cost of health insurance.

The contradictions and counter claims are endless.

We in the IBEW are in a unique situation to truly see the effect of this. By having our own health insurance we are under the same regulations and rules as private insurance companies but we do not have the profit motive driving up the costs of our insurance plan. So does requiring insurance companies to cover dependent kids in college until 26, not allowing them to deny coverage to people with preexisting conditions, not capping the benefits so if you have a serious illness they can drop you if

it is 'too expensive' actually drive the costs of insurance too high? Across the nation we have heard about huge increase in health insurance due to this legislation. Insurance company associations have claimed it has caused increases from 19-30%.

But when you look beyond the pundits on TV and beyond the press releases of insurance companies – how much did these requirements really cost? Our insurance plan has not increased in the past three years. So during this whole fight and seeing private insurance companies do double digit increases every year saying it is Obama Care causing it – why hasn't our premium increased? Because the real truth was these provisions were about making health care affordable and protecting families from bankruptcy over health care – making sure the money already going to insurance companies actually went to health care and not just to larger CEO salaries and bonuses.

That is why so much of politics and government policy takes a lot more to figure out than just hearing the title of the policy or the 30 second political sound bite. The Affordable Care Act didn't drive up rates – the profit motive of private insurance and hospitals did.

Whenever you hear a slick line or name for a policy always look under the hood. The 'tools' Walker gave to local governments was a euphemism for cutting pay and benefits. This type of misdirection is to keep us all confused. So as election time comes around make sure to look under that hood or you could be buying a great looking car that has no engine.
