Class Fees

Over the last few months there have been major changes to our education programs. First, Madison College without warning, raised the tuition fees for night classes up to 3 times over what they were from the previous year. To deal with this drastic increase, the Joint Apprenticeship Trust (JAT) and the joint Apprenticeship Committee (JAC) elected move more classes to the training center and virtually just rent rooms from the college for the rest of the night classes. With these changes, Madison College no longer collects the tuition costs for the classes. The duty of accessing fees and collecting now falls on the JAT/JAC. After evaluating all costs associated with holding classes, a fee of \$7.00 per hour of instruction was determined as a starting point. This amount is much less than the college was levying but still should cover all costs associated with holding classes.

The second issue that we faced this summer was the unprecedented number of new apprentices entering our program this year. With 76 first year apprentices, we are starting 4 classes of students as opposed to the 1 or 2 classes we have for the current apprentice classes. To handle the night school requirements for apprentices, the training center is fully booked Monday through Wednesday for both fall and spring classes.

With the new fee structure in place, the committees have discussed how continuing education classes may or may not be affected. As of this writing, only the "Significant Changes" class has been scheduled. The discussion on waiving the fee for this course I suspect will be completed in the next few weeks.

Apprentice Reimbursement Policy

The tuition reimbursement policy for apprentices is also in the process of change. The first change was to eliminate the barriers or "hoops to jump through" in order to receive reimbursement. Once eliminated, apprentices came forward and pointed out that the new plan actually put more burden on the newest apprentices who need the help most. The committee has since adjusted the reimbursement plan as to favor newer apprentices. There is still room for improvement and change. I encourage members to speak up and address their concerns to the JAC in order to come to the best resolution for our educational system.

Attendance Drawing

At the September membership meeting we had a winner for the monthly attendance drawing. Congratulations to Youssef Amraoui, for winning the drawing and while attending his first membership meeting. Youssef, won the \$900 pot so now the pot resets to \$100.

As I mentioned at the membership meeting we have changed the Administrative Rules for Registration and Referral of Applicants for Employment #8 which **currently reads**:

8. Applicants will be allowed two turndowns (strikes) without penalty and will be removed from the book for a third turndown. Turndowns are only given when a call cannot be filled from Group 1 or Group 2 applicants. You must re-register in person after being removed from a book (Not applicable to short calls or specialty calls)

8. Applicants will be allowed two turndowns (strikes) without penalty and will be removed from their current position and moved to the last position on their appropriate book for a third turndown. Turndowns are only given when a call cannot be filled from Group 1 or Group 2 applicants. Only 1 strike will be given for any specific Manpower Request (call) not filled. Short calls or specialty calls will not be given a strike.

This rule will take effect on November 1st 2018. If anyone has a question or suggestion on language change please leave me a message.

Our October 8th Luncheon will be at Murphy's Bar & Restaurant on Highway 113. Hope to see there!

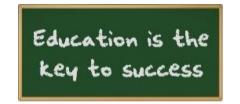

Death benefits are assessed for any active or retired member who passes away. Active members pay \$1.00 for each death benefit. This is also a benefit for all #159 active and retired members. We are currently on death benefit #250. If you currently have your union dues set up on auto pay with your bank, make sure you are sending \$38.75 each month. Remember to check on death benefits. We accept checks, cash (in person), debit/credit cards (in person or by phone during business hours) and money orders.
